Regional Standards Settlement

Court Accepts Settlement Agreement, Ends Lawsuit Over Regional Standards

The U.S. District Court of Appeals for the DC Circuit issued an order today accepting a settlement agreement thereby ending the legal challenge of the Department of Energy's (DOE) 2011 rules that setting new minimum energy conservation standards for a variety of residential HVAC products, including regional standards for furnaces and central air conditioners.

ACCA was one of several parties of record in this case.

ACCA created a detailed explanation of the settlement and its impact on contractors. **That document is available to by ACCA members only (login required).**

ACCA members can watch a special online briefing on the regional standards issue that was recorded on May 25 on-demand now.

"We are thankful that the Court accepted the settlement motion and ended this prolonged lawsuit," said Paul T. Stalknecht, ACCA president & CEO. "The settlement vindicates ACCA's concerns about the DOE requiring condensing furnaces without regard for potential impact on homeowners. We are also pleased to see that our comments aren't likely to be overlooked in future rulemakings. Now the industry can move forward to develop an enforcement plan for the regional standards on split system and single package central air conditioners."

Under the terms of the proposed settlement:

Regional standards for non-weatherized natural gas and mobile home furnace are rescinded.

The DOE will rewrite new standards for non-weatherized natural gas and mobile home furnaces within two years.

Regional standards for central air conditioners go into effect on January 1, 2015.

13 SEER central air conditioners manufactured before January 1, 2015, may be installed in South and Southwest regions during an 18 month grace period ending July 1, 2016.

The DOE will initiate stakeholder-led negotiated rulemaking on enforcement for regional standards for central air conditioners.

The DOE will initiate a rulemaking to clarify the expedited standard setting process known as the Direct Final Rule.

HVAC Is Undervalued

Dave Kyle: HVAC Is Undervalued; Time to Invest, Re-brand

ACCA 2014 Chairman David Kyle offered up a bold presentation at the association's annual conference in Nashville. He pointed out that contractors today are, quite literally, still struggling with the same business problems they were talking about 50 years ago.

Yet American contractors — almost all *very* small businesses — control a huge segment of the global economy, which has caught the eye of numerous high-tech competitors seeking to take over "the connected home."

Kyle said that the industry needs to re-brand itself as the high-tech industry that it has become, because people outside (including potential future employees) have an old-fashioned view of "HVAC."

"We are undervalued," Kyle said. "When something is undervalued, that means it's a great time to invest."

ENERGY STAR Proposes New A/C and HP Specification

The U.S. Environmental Protection Agency (EPA) is proposing changes to the specifications for central air conditioners (CAC) and air source heat pumps (ASHP) earning the ENERGY STAR mark. The specification changes are necessary in light of the pending increase in the federal Department of Energy (DOE) energy conservation standards for CAC and ASHP that go into effect on January 1, 2015. For some product categories, the new federal energy conservation standards will be equal to the current ENERGY STAR specification, thus the need for a change. ENERGY STAR branded products represent the top product category performers in terms of energy efficiency and providing significant energy and cost savings to the consumer.

The proposed specification changes apply to four product categories: split system central air conditioners, split system air source heat pumps, single package central air conditioners, and single package air source heat pumps. For only split system heat pumps, the proposed specification is regionalized, setting a more stringent specification in the South region than the North. The specifications for the other product categories are national in scope.

Below is a chart showing the current and proposed Energy Star product specification by product category.

Changing to a regional specification for split system central air conditioners will require adjustments to the ENERGY STAR label that appears on the equipment to signify equipment compliant in the North region.

The EPA will be taking comments on the proposed changes until May 16, 2014. Based on all submitted comments, the EPA will release a second draft of the proposed specification for comment before issuing new specifications that would likely go into effect in the second quarter of 2015. Contractor Comfort Index

Contractor Comfort Index 81 in April; Up 10 from 2013

The April Contractor
Comfort Index (CCI) shows
that contractors' optimism
about short-term growth is
increasing as spring is just
beginning. ACCA began
measuring contractor
attitudes toward short-term
economic growth with the
CCI in February 2010.

For April 2014, the CCI is 81; the highest the CCI has ever been in the four years ACCA has tracked contractors' opinions through the survey. The CCI also shows that contractors are feeling better than they were 12 months earlier when the CCI was 71.

The CCI is calculated based on a survey of the association's contractor members, who are asked how positive they feel about new business prospects, existing business activity, and expected staffing decisions in the short-term future. Weighted and averaged into one number, a CCI of 50 or above reflects anticipated growth.

The CCI is released prior to the start of each month; the next index number will be released during the last week of May.
